AND WHEREAS the designated partners intend to utilize the LLP's internal funds for investments across various sectors, they have accordingly amended the existing objectives of the LLP.

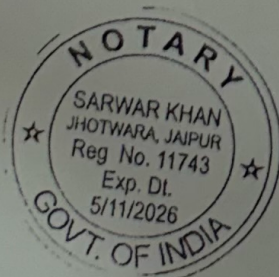

The revised capital contribution of the LLP shall be of Rs. 50,000/-. The same shall be contributed by the parties in the following manner:

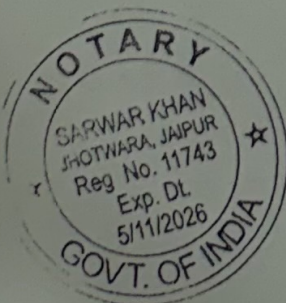

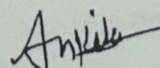


8. The Designated Partners/Partners shall be entitled to share the profits and bear the losses of the LLP as per the mutual consent between the Parties as well as in the ratio
